Re: Phoenix Sinclair Inquiry – Full Standing request

Dear Sherri,

Please accept this letter as request for standing in the Phoenix Sinclair inquiry. I am the Chair of the Northend Action Group (NAG) Inc., the only CFS advocacy group in the province that has been trying to raise awareness to the CFS atrocity here in Manitoba.

I am also the family advocate for Gage Guimond and the Guimond family, and have over 50 families on our current caseload (representing over 100 children in care), all whom have experienced conflict with today's current child welfare system.

On August 13, 2010, myself and several families were to appear before a judge concerning Private Prosecutions of CFS workers who've committed crimes ranging from Obstruction, Perjury and Kidnapping. Mysteriously, an uttering threats charge was fabricated by police, CFS and the Southern Authority and on August 10th, 2010 I was arrested detained without bail, and maliciously prosecuted. I was detained for 6 months, and CFS won permanent ward of my children. I haven't seen my children since December 23, 2010 a full 18 months.

Nevertheless, our group will be releasing our first report on Manitoba's Child Welfare shortly, and it focuses on all components which have an interest, directly or indirectly and it will evaluate and show how the system of "Devolution" is a complete failure and has resulted in over 300 deaths in the last 5 years.

I have 1,000's of documents that I will use to tell the story of CFS and "Devolution" in Manitoba, and how all have stood together to protect the integrity of one Elsie Flette, the CFS Act and Authorities Act of Manitoba, all 3 considerable failures.
