PRESENTING PROBLEM/ INTERVENTION:

[REDACTED] called to speak with Kathryn Epps, as she is needing some advise. [REDACTED] advised that Kathryn attended to her work place today to discuss some serious concerns with the lack of appropriate care by mom for [REDACTED]

According to source, Samantha Kematch [REDACTED] has abandoned both of her very young children and given Steve Sinclair (dad) custody of them. However, yesterday Samanitha attended to Steve's home at 740 B Magnus with the Winnipeg Police to have her baby [REDACTED] returned to her. Police assisted her with this matter.

Tonight, Samantha called Steve to tell him to come and pick up [REDACTED] as she is not prepared to attend to her any longer. According to source, Samantha told Steve that she has to wait for her GST cheque and has other plans for tonight. The problem being is that neither Steve or Samantha can have contact with each other. This worker asked if there was any legal agreement between Steve and Samantha regarding custody, guardianship and access. Source stated that no, there was no formal court papers. This worker directed the source to tell her brother to call the Winnipeg Police for assistance with this matter tonight.

This worker provided source with the assign worker's direct line for Steve to have further discuss regarding the well being of the babies. Sources reports that Samantha has nothing to do with Phoenix and dropped both the children off on dad about two months ago.

Source did not know the proper address for Samantha, but believes that she is living with CIC [REDACTED] on Blake St. source also noted that Samantha is very unstable and not a good influence for [REDACTED]

RECOMMENDATION:

It is recommended that the assign workers further assess the above concerns. Regarding Samantha, to determine if she is stable enough to have her children with her or if she has abandoned them. As for [REDACTED], it would be important to know if she is having Samantha live with her while it is alleged that Samantha is abusing alcohol.
