regarding a possible homicide at the Fisher River Indian Reserve.

On arrival, several minutes later, crew met and spoke with DOGHES who advised of the following.

with her former husband Karl "Wesley" MCKAY. According to the two boys had gone to Fisher River Reserve to visit with their father in the month or August 2005. She reported that following their return both boys had begun to act differently and that both were beginning to get into trouble, both at home and at school. She then went on to advise that on Friday, 06 03 03, the oldest boy the had divulged to her that his father "Wesley" had killed a five year old girl who was the daughter of Wesley's" live-in girlfriend.

vas uncertain as the girlfriend's name but thought that it was Samantha KEEMAUH. According to DEFS, DEFEZ told her that the little girl whose name DEFS didn't know was choked and thrown down a flight of stairs to the basement. The little girl apparently fractured her skull and died from her injuries and that "Wesley" then buried the body in the back yard. DEFES said that she believed her son because of his demeanour when he tout the story adding that he appeared physically shaken as though he was unburdening himself.

DOE#3 then confronted her younger son DOE with the information she had received from DOE 2 and she indicated that he immediately became upset with DOE#2 wanting to know why he had told his mother this information. DOE#3 said that DOE#1 confirmed what DOE#2 had told her although he wouldn't say whether he had actually witnessed the incident or not. She indicated that DOE 2 told her he had seen the little girl as she was being buried and could see her fingers sticking out of the dirt.

went on to say that the boys then divulged several incidents of abuse towards the young girl which included "Wesley" on a number of occasions doing what they refer to as "choking the chicken." DOS #3 said her boys explained that choking the chicken meant choking the little girl till she passed out. DOS#3 lalso said that "Wesley" would use a BB gun to shoot the little girl and that he forced the two boys to do the same.

advised that to her knowledge the little girl would be a natural biological daughter of "Wesley's" present girlfriend. She also indicated that the boys were told by both the girlfriend, who is apparently aware of this incident, and Karl that if anyone asked they were to say that the girl had gone to live with her biological father at an unknown location.

then advised this crew that she had seen this girl on one occasion which she believed was in April 2005 when "Wesley" was waiting out front of her residence in his vehicle. At that time she said that the girl had what appeared to be a fresh head injury and was wrapped in a blanket and shaking. Said that "Wesley" had told her that the girl was prone to injury and had recently banged her head.
